



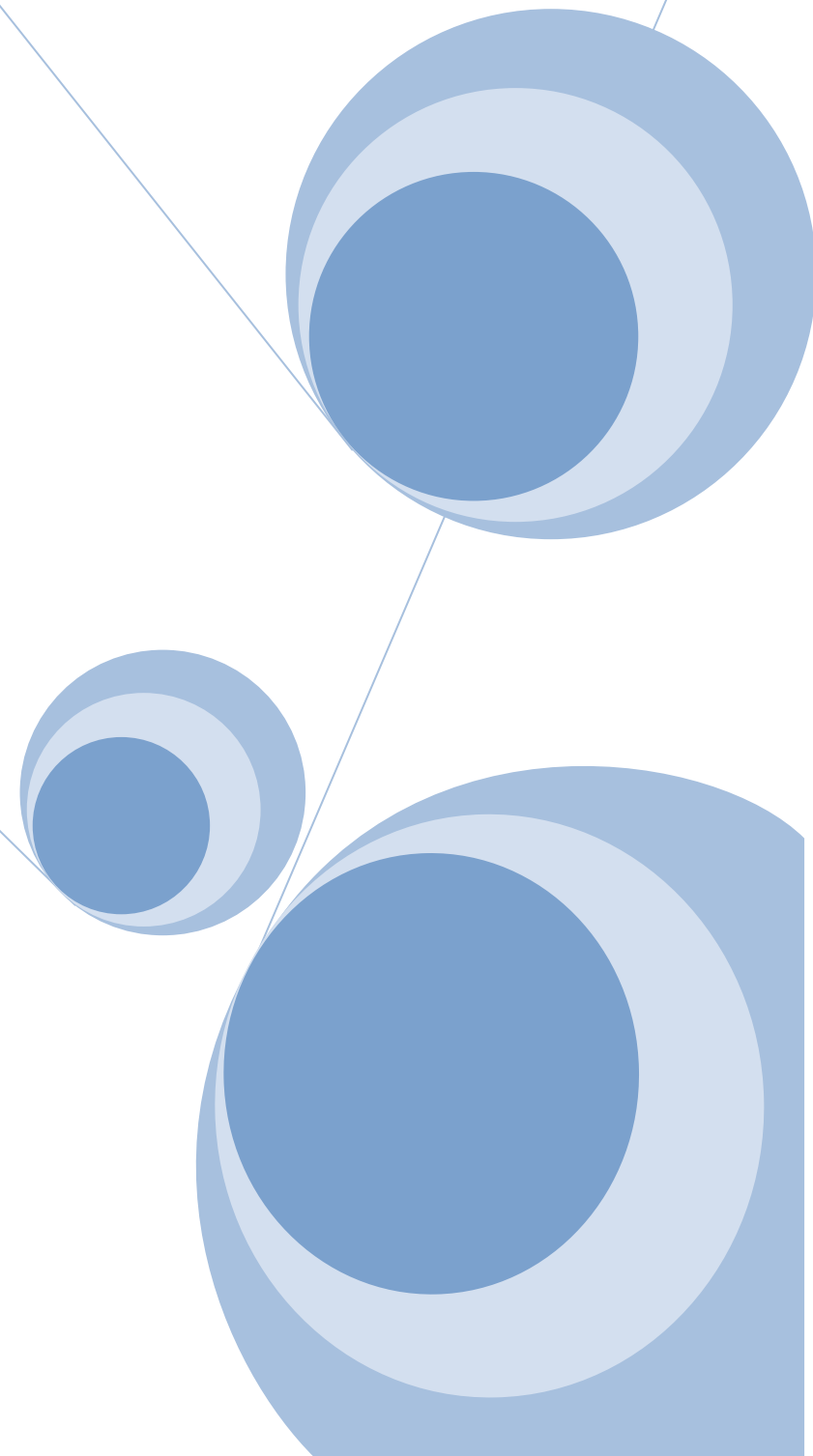

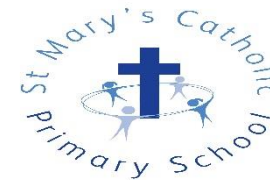

- **The deployment of learning support**
- **Staff Information**
- **Staff Training**
- **Grouping arrangements**
- **Peer Support**

### **3. IMPROVEMENTS TO THE PHYSICAL ENVIRONMENT**

- This may include:-
- Lighting
- Signing
- Improvements to the acoustic environment
- Floor coverings
- Toilets and washing facilities
- Furniture
- Layout of the playground
- Adaptable workbenches
- Steps & Stairways
- Parking areas
- Entrance / Exits (Including internal & external doors)
- Décor
- Exterior Surfaces
- Use of different chairs/tables when advised by PIMIS

### **4. IMPROVING THE DELIVERY OF INFORMATION TO DISABLED PUPILS**

This may include:-

- Handouts
- Text books
- Information about school events
- Homework
- Accessibility of school website

It might include making information available;

- In Braille
- In large print
- Through sign language
- Using a symbol system
- In a different language
- On audio tape
